

DESCRIPTION OF VALUATION OPTIONS for LOCAL/INTRASTATE/STORAGE

PLEASE TAKE A MOMENT...

Citizens Transfer & Storage has been family-owned and operator for over 90 years. Our company goal has always been EXCELLENCE in service to our customers. We are very proud of our reputation and we work hard to maintain it. However, mishaps can occur. To provide for this possibility, we offer several types of additional protection. The options vary in cost and limits of protection. Decisions regarding the value of your possessions must be made by you. The valuation level must be determined prior to performance of any services. So please take a moment to review your options.

EXTRA CARE PROTECTION (ECP)

When you request, in writing, Full Replacement offered by the ECP Plan, Citizens Transfer & Storage will either repair, replace or reimburse (whichever is less) for any damages or loss during the move, up to the declared limits of liability. Replacement value is full current cost replacement, not depreciated value. In order to obtain full coverage, you must include the value of all the goods being moved, not just selected pieces.

Charges for full replacement protection depend upon the deductible option you have selected and the value you place on your shipment. You must declare a minimum value equal to at least \$5.00 per pound times the weight of your shipment or an amount more than this minimum. Your homeowner's or renter's insurance policy can help you decide on your declaration of value. All possessions of exceptional value should have appraisals.

BASIC LIABILITY PROTECTION

This coverage is at no extra cost. It provides reimbursement up to \$.30 per pound for loss or damages. For example, the coverage on a 100 pound television is calculated at \$.30 x 100 pounds = \$30.00. In general, this plan is used when a homeowner's policy or an employer's policy already provides adequate protection.
